Douglas County Republican Central Committee General Meeting March 12, 2009

The regular general meeting of the DCRCC called to order by Chair Maggie Benz, March 12, 2009 at 7:20P.M. at Republican Headquarters in Gardnerville, Nevada. Wes Rice gave the Invocation and Commissioner Mike Olsen led the Pledge of Allegiance to the Flag of the United States of America. 54 members present and quorum met.

Program:

Doug Mathews introduced quest speaker Bruce James, Chair of Spending & Government Efficiency Commission (SAGE)

Commissioner James explained forming of commission and gave the following facts:

His job is to solve long-term problems and to harness business people; Formed bipartisan group; Needed good idea people; Committee is privately financed; Commission reports every 90 days with Governor reporting back every 90 days on how recommendations are being implemented; Looking at how to do better job of services and how to better spend money; They formed task forces with experts; Found the need for state policies.; Six agencies have 80% of money and each agency has a sunset provision (10yrs.) also agencies are tax exempt; All state employees were surveyed; Change of PERS is needed as the health benefits are 80% of personnel cost.
