The articles typically come from the Chicago Tribune, Chicago Sun-Times, Daily Herald, Daily Southtown, ABC7, NBC5, CBS2, Crain's Chicago Business, Springfield State Journal-Register, Belleville News Democrat, St. Louis Post-Dispatch, Rockford Register Star, Peoria Journal Star, Bloomington Pantagraph, Southern Illinoisan, Suburban Chicago News, Liberty Suburban News, Pioneer Local, Illinois Family Institute, Public Affairs, Tom Roeser, and Family Taxpayers Network. As many of you know, I am a conservative and a "platform" Republican. I have not accepted any compensation for what I have been doing as the GOPUSA Illinois Editor since 2000 and I will not accept compensation for that work. Sadly, anti-conservatives and those who want to control what I include in the emails badmouth me and the emails.
